

Northern Graphite Corporation Bissett Creek Graphite Mine Information Centre

YOU ARE INVITED!

Northern Graphite Corporation is planning to construct, operate and ultimately decommission a graphite mine in Maria Township. The Bissett Creek Graphite Mine is anticipated to have an 18-year mine life. This activity is subject to the *Mining Act* and falls under the jurisdiction of the Ministry of Northern Development and Mines. The Ministry of Natural Resources and Forestry (MNRF), Pembroke District has received application for approvals and permits to authorize the proposed activities listed above associated with the mine. Northern Graphite invites AOO communities to learn about and provide comment on the proposed approvals and permits related to the proposed Bissett Creek Graphite Mine. Northern Graphite will require approvals and permits for the following proposed projects under the Class Environmental Assessment for MNR Resource Stewardship and Facility Development Projects:

- Construction and Upgrade of Access Roads and Watercrossings
- Disposition of Crown Land for a Natural Gas Station
- Harvest of Crown Timber
- Authorizations under the Fish and Wildlife Conservation Act
- Location and Design of Water Impoundment Structures
- Extraction of Crown Aggregates
- Activities With Conditions to Achieve Overall Benefit to a Species

The information centre will be a drop-in style open house that introduces the proposed mine and provides information on the site location and proposed activities. This notice is provided in accordance with the Class Environmental Assessment for MNR Resource Stewardship and Facility Development Projects. The Project has been screened to a Category C in anticipation of Aboriginal and public interest. *To learn more, we invite you to attend one of the upcoming sessions. 
