The company manages approximately 190,000 hectares of FSC® (SA-FM/COC-003811) Certified Crown land in the Great Lakes-St. Lawrence Forest of southeastern Ontario.

Based out of the company office located in Cloyne Ontario, the **Company Forester** will work as part of a small team under the direction of the General Manager.

Responsibilities of this position include, but are not limited to the following:

- Leading the development of the Forest Operations Prescriptions and their effective implementation;
- Coordination and implementation of the company renewal, tending and monitoring programs;
- Assist in the development of the Forest Management Plan;
- Lead the management of Forestry Futures funding projects;
- Assist in meeting the requirements for company Independent Forest Audits (IFAs) and Forest Stewardship Council<sup>®</sup> SA-FM/COC-003811 certification;
- Provide prompt service to shareholders, overlapping licensees, contractors and clients of the company;
- Assist the General Manager and company staff in day-to-day operations of the company and provide advice on matters related to forest management and planning

- Understanding of the Forest Management Planning process and related manuals;
- Experience working in the Great Lakes-St. Lawrence Forest will be considered an important asset;

- Must be able to work in a team environment to strategically solve problems;
