Anniin, hello my name is Heidi Kimberley, I am a decendant of Francois Celeron Wabechkipenisi Laronde.

I have been researching Francois for my membership with the Metis Nation of Ontario.

I would like to share documents with you that are being verified through MNO.

Attached are:

- 1. Last will and testament of Louis denys de Laronde naming his wife Marie Magdeline Wosnesquigogo and their 10 children. I will supply a translated version and the original document all acquired through the Montreal Archives.
- 2. The baptism of Marie Ne8tjikijikok8e ay OK July 29th 1802. I have also noted that Marie Ne8tjikijiekthok8e was also in OKA baptizing another two daughters in June.

I would be interested in the Algonquin traditional knowledge regarding 2 names that Marie went by if you would be kind enough to share with me.

3. The baptism of Toussaint Laronde naming his mother Marie Magdeline Wosnesquigogo in 1793.

I am not seeking membership with the Algonquins of Ontario.

I am sharing the history that I have acquired after years of work. This is our history and I want to share what I have found.

Again, I have submitted all this information and more to the Metis Nation of Ontario, they have had it under review since May 28th, 2022 official verification is still underway.

I have given Terre Chartrand all this information, she has told me she will be attending the membership tribunal.

I would appreciate a knowledge exchange with an Algonquin historian, I have been unable to find a death record for Marie, it is rumoured she died around 1803, likely later in the year. I have been unable to find any record of her death in OKA.

I sincerely appreciate your time and attention.


